

ARTICLES OF INCORPORATION.

I.

The name of this corporation shall be the "Craig Mountain Gold-Copper Mining Company (Limited)".

II.

Said corporation is formed for the purpose of mining, milling and selling ore, the building of mills, tramways, dams, canals and highways; to purchase, mortgage, lease and sell all kinds of mining properties, and to engage generally in the business of mining and development of mineral lands, and to do all things that may be necessary or incident to the best interests of the corporation.

III.

The principal place for the transaction of the business of said corporation shall be the city of Lewiston, in the state of Idaho.

IV.

Said corporation shall exist for the period of fifty years.
