ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF SERVISELL, INC.

* * * * *

Pursuant to the provisions of the Idaho Business

Corporation Act, Servisell, Inc. adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SERVISELL, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the stockholders of the corporation on December 12, 1990, in the manner prescribed by the laws of the State of Idaho, and the By-Laws of the corporation:

RESOLVED, That ARTICLE III entitled PURPOSES, is hereby amended by adding to said Article III, Paragraph 3, to read as follows:

3. To act as agent for insurance companies in soliciting and receiving applications for insurance of all kinds, collecting premiums, and doing such other business as may be delegated to agents by such companies.

RESOLVED FURTHER, That the President and Secretary of the corporation, be, and they are hereby authorized to execute the Amendment of the Articles of Incorporation of Servisell, Inc., for submission to the office of the Secretary of State, authorizing the corporation to act as agent for insurance companies.

THIRD: Number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

FOURTH: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was none.
