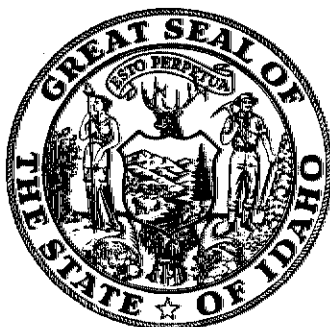

ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation for the purpose hereinafter set forth under and in conformity with the laws of the State of Idaho, hereby submits this written certificate in duplicate, and certifies:

FIRST: The name of the corporation shall be MATKIN EXCAVATION, INC..

SECOND: The corporation shall exist perpetually

THIRD: This corporation is formed for the purpose of engaging in and doing any lawful act concerning any and all lawful businesses for which corporations may be organized under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue One Hundred Thousand (100,000) shares, without par value. All stock shall be of one class and shall be fully paid and non-assessable when issued.

FIFTH: The initial registered office shall be 873 South 100 West, Victor, Idaho 83422. The registered agent at such address shall be Stephen Matkin.

SIXTH: The management of the corporation shall be vested in a board of two directors until such time that the stock shall be held by more than one shareholder, either beneficially or of record, at which time the number of directors shall be increased to the same amount of shareholders, to a maximum of five. 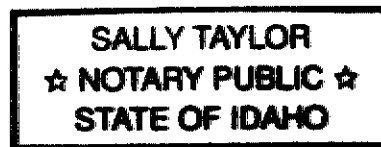
