CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF CHILDREN'S HOME SOCIETY OF IDAHO

KNOW ALL MEN BY THESE PRESENTS: That the CHILDREN'S HOME SOCIETY OF IDAHO, a corporation, organized and existing under and by virtue of the laws of the State of Idaho, by and through the undersigned, the president and secretary, respectively, of said corporation, does hereby make and execute the following Certificate of Amendment to its Articles of Incorporation and does hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

- l. That a meeting of the members of the corporation was duly called, convened and held in the manner provided by law and by the By-Laws of said corporation, including publication of notice thereof as required by Chapter 11 of Title 30, Idaho Code, at the offices of said company in the City of Boise, on the day of ________, 1966, at 12:30 o'clock noon, and that notice of said meeting was duly published as shown by an affidavit of publication certifying said publication being attached hereto.
- 2. That at said meeting a quorum attended, and the following resolution was unanimously adopted, to-wit:

"BE IT RESOLVED, that the following Articles of the Articles of Incorporation of the Children's Home Society of Idaho be amended in the following particulars:

a. That Article Fifth be deleted and the following paragraph inserted in place thereof:

FIFTH

The persons who have subscribed these Articles of Incorporation and those persons who become members in accordance with the provisions of this Article shall constitute the membership of said corporation.

The By-Laws may prescribe the terms of membership which membership may consist of more than one class. Any person may become a member of the corporation by meeting such terms and by the payment of the membership fee required in the By-Laws.'

- b. That Article SIXTH of the Articles of Incorporation be amended by deleting the last and fourth paragraph thereof.
- c. That Article EIGHTH of the Articles of Incorporation be deleted and the following paragraph be inserted in place thereof:

'EIGHTH

The annual meeting of the corporation shall be held at its principal office in the City of Boise, the third Thursday in September in each year, at 12:30 noon of that day. The Board of Directors may, by resolution and due notice to the members, designate some other place in the City of Boise for holding such meeting, and special meetings of the membership of the corporation may be held in the City of Boise at such time, place and manner and upon such notice as may be prescribed by the By-Laws.'

AND, BE IT FURTHER RESOLVED, that the President and the Secretary of the corporation be and they hereby are, directed and empowered to cause a proper certificate of amendment to the Articles of Incorporation of this corporation to be executed and filed with the Secretary of the State of Idaho and with the recorder of Ada County of such state in compliance with the statutes of the State of Idaho in such case made and provided."




