ARTICLES OF INCORPORATION

OF

PROMAR, INC.

The undersigned, being natural persons of legals and acting as incorporators of a corporation under the Idaho Business Corporations Act, Title 30, Chapter 1, Idaho Code, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is PROMAR, INC.

ARTICLE II

The period of the duration of the corporation shall be perpetual.
