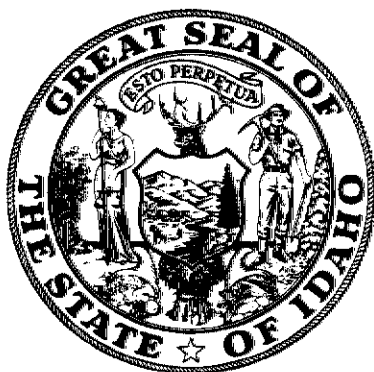

ARTICLES OF INCORPORATION  
OF  
BINGHAM COUNTY CRIME STOPPERS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a non-profit cooperative association for the purposes set forth herein, pursuant to the law of the State of Idaho, do hereby certify as follows:

ARTICLE I.

The name of the corporation shall be Bingham County Crime Stoppers, Inc.

ARTICLE II.

The corporation is a non-profit corporation.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purposes of the corporation shall be:

1. To promote law abidance by the citizens of Idaho, particularly in Bingham County.
2. To educate citizens about the laws of Idaho, ordinances of Bingham County and the cities within Bingham County.
3. To provide a fund, through donations, grants and other sources, to provide rewards for information leading to the arrest and prosecution of persons committing crimes in Idaho, particularly in Bingham County.
4. To aid in the recovery of stolen articles of personal property.
5. To promote cooperation and participation by citizens in aiding law enforcement in the State of Idaho, particularly in Bingham County.

#### ARTICLE IX.

The Corporation is not organized for a pecuniary profit. It shall have no power to issue stock, declare dividends, nor to dispense any monies to any of its members, director, or officers, except to reimburse for actual expenses incurred in promoting and carrying out the purposes of the Corporation.

All monies received by the Corporation shall be used for the purposes of the Corporation or for charitable, scientific and/or educational purposes.

#### ARTICLE X.

Members of the Corporation shall all be members of the Board of Directors of the Corporation, which Board shall consist of nine (9) members. The number of Directors may be increased or decreased by majority vote of the members from time to time, but shall not be decreased to less than three (3) nor increased to more than fifteen (15). New or replacement members shall be admitted upon majority vote.

Members shall serve for three (3) year terms. No unexpired terms shall be filled.

Assessments may not be made against any member.

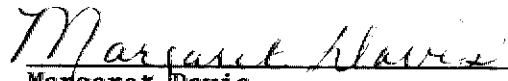
#### ARTICLE XIII.
