- 1. NAME: The name of the corporation is PREMIUM SELECT, INC.
- 2. **DURATION:** The period of it's duration is perpetual.
- 3. **PROFIT**: This is a profit corporation.
- 4. <u>PURPOSES</u>: The purposes or purposes for which the corporation is organized is to operate a potato processing plant and related businesses and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- 5. SHARES AUTHORIZED: The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND (10,000) shares of no par value common stock.
