

ARTICLES OF INCORPORATION  
of the  
GAMMA THETA CHAPTER OF KAPPA SIGMA  
--- 0 ---

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, the majority of whom are residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the corporation laws of the State of Idaho, and in pursuance of the purposes for which we have been elected as hereinafter set forth, a fraternal corporation to be known as The Gamma Theta Chapter of Kappa Sigma, and we certify:

First. That the objects and purposes for which this corporation is formed are: To provide for the social and fraternal advancement of its members; their pleasant, beneficial and agreeable association; their mutual exchange of ideas; and the promotion of social and fraternal intercourse; to acquire, by purchase or otherwise, real estate, improved or unimproved, or personal property of any kind that may be deemed necessary or expedient for the carrying out of the purposes of this corporation; to do all things lawful and incident to the purposes of the said corporation not inconsistent with the laws of the State of Idaho; and for the purpose of carrying out the objects of this corporation, to issue bonds in any amount authorized by law, to secure funds for corporate purposes, and to secure the same by mortgage or deed of trust upon the whole or any part of the real and personal property of the corporation, at any time held by it; and, in fact, to do and perform every act and thing necessary or expedient to carry out the above named purposes.

Second. The principal place of business of said corporation shall be in the city of Moscow, County of Latah, State of Idaho, and the directors of the corporation shall have the right to establish a branch office in any other state or states, as deemed necessary, expedient, or desirable.

Third. The term for which said corporation shall exist shall be fifty (50) years from the date of its incorporation.

Fourth. That the directors shall have full power to make such prudential by-laws as they may deem proper for the management of the affairs of said corporation not inconsistent with the laws of the State of Idaho and with these Articles of Incorporation for the purpose of carrying out the business, purposes and objects of this corporation.

Fifth. That the number of directors who shall have the management and control of its affairs as aforesaid shall be five (5), and the names of the directors elected for the first year are:

Each and every one of the above named directors received the unanimous vote of the seventeen (17) members present, (Chairman not voting.)

That the said directors were duly elected at a meeting of the members of said Fraternity, duly convened and held at their Chap-House at No. 804 Washington St., in the said city of Moscow, County of Latah, State of Idaho, for the purpose, among other things, of electing directors to take charge of and manage its property, temporalities and affairs, and to form this incorporation. That a majority of said members were then and there present and voted at such election for the above named directors, as is more particularly set forth in the certificate and verification of the officers that conducted the election hereto annexed and made part of these Articles.
