

Certificate of Incorporation of the
Ada County Publishing Company
Idaho Territory.

A Corporation formed for the purpose of
Publishing a Democratic Newspaper in
Boise City Ada County Idaho Territory.

Article 1st

The Corporate Name of said Company
is and shall be The Ada County Pub-
lishing Company.

Article 2d

The Principal place of business of
said Corporation shall be at Boise City
Ada County Idaho Territory.

Article 3d

The object for which this Corporation is
formed is to publish a Democratic News
paper in said Boise City Ada County
Idaho Territory and to do a General
Printing business.

Article 4th

The amount of Capital Stock of this
Corporation shall be and is the sum of
Five thousand Dollars, and the same
shall be divided into Five Hundred
shares of Ten Dollars per share.

Article 5th

This Corporation shall continue for the
period of Twenty Years from the date
of signing and acknowledging these
articles of Incorporation.

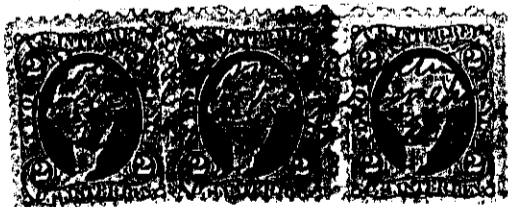
