SECRETARY UT STATE Articles of Incorporation of the undersigned, a majority of whom are citizens and the United States, desiring to form a Non-Profit Corporation under the Non-Profit Law of Idaho, do hereby certify:

First: The name of the Corporation shall be Miss Kimberly Scholarship Pageant, Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Kimberly, Twin Falls, County, Idaho.

Third: Said corporation is organized exclusively for educational purposes, the making of distributions to students that qualify as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees and board members of the corporation are as follows:

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carring on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
