



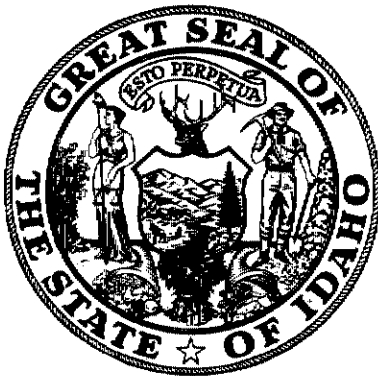
**CERTIFICATE OF INCORPORATION

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act adopt the following articles of incorporation:

ARTICLE ONE

Corporate Name.

The name of the corporation is Best Cut Wood Products, Inc.

ARTICLE TWO

Purpose.

The purposes of the corporation is to engage in the business of preparing, processing, and otherwise manufacturing and purchasing, trading, and dealing in for resale millwork products composed in whole or in part of wood or wood products. Also to manufacture , buy, sell, import, export, and deal in receptacles, packages, containers, and other articles and packing devices, made of wood or other materials; and to manufacture and deal in packing devices generally for all classes of goods, wares, and merchandise. To engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE

Duration.

The period of duration of the corporation is perpetual.

ARTICLE FOUR

Registered Office and Agent.

ARTICLE FIVE

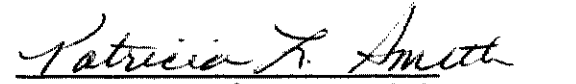
