Dear Mr. Brandt:

Your letter dated July 19, 2008 requesting approval of the company name "Clain's Real Estate and Banking Briefs" for use in the state of Idaho has been received by the Idaho Department of Finance (Department) and has been reviewed by Department staff. From your letter and attachments, we understand that Clain's Real Estate and Banking Briefs provides a newsletter concerning financial-related matters on a subscription basis. We also understand that such company will not operate in Idaho as a depository or financial institution.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to your company's use in Idaho of the name "Clain's Real Estate and Banking Briefs." Because Clain's Real Estate and Banking Briefs will limit its Idaho business activities to a newsletter and related services, we do not believe the name proposed by your company for use in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
