ARTICLES OF INCORPORATION
for a non-profit corporation
of Idaho

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation pursuant to the non-profit laws of the State of Idaho.

And we hereby certify:

ARTICLE I.

That the name of the Corporation shall be "FARRAGUT BOOSTERS, INC." and its duration shall be perpetual.

ARTICLE II.

That the specific and primary purposes in addition to those that are granted by statute for which said Corporation is formed are: To recognize and promote the World Boy Scout Jamboree to be held at Farragut State Park at Farragut, Idaho, during the calendar year of 1967 and to function preliminary and subsequent thereto for the purpose of sanctioning and promoting any and all activities incident to the proper promotion thereof insofar as the communities surrounding Farragut State Park may do for the purpose of

promoting and cooperating with all agencies incident to the conduct of said Boy Scout World Jamboree to be held at Farragut State Park and to issue literature, bring recognition to the public into the world of its endeavors including the issuance and publication of literature and any other promotional devices not for profit.

It shall also have the power and the right to contribute its net proceeds upon dissolution, to the Panhandle Council of Boy Scouts of America officed at Coeur d'Alene, Idaho, in accordance with the applicable law, rules and regulations, and for this purpose, to lease, purchase, hold, and take and use in fee simple or otherwise, any real or personal property, and to use, dispose of, pledge, alienate or otherwise profitably and with good purpose and intent within the foregoing purposes, conduct the affairs of said corporation.

ARTICLE III.

That the County and State of Idaho where the principal office for the transaction of the business of this corporation is to be 601 Sherman Avenue, Coeur d'Alene, Kootenai County, Idaho.

ARTICLE IV.

That the names and addresses of the persons

who are to act in the capacity as Directors until the selection of their successors and shall be known as Directors until their successors are qualified, are:

The number of persons named above shall constitute the number of Directors of the corporation until changed by an Amendment to the By-Laws increasing

or decreasing the number of Directors as may be desired.

ARTICLE V.

That the authorized number and qualification of the members of this Corporation of which there shall be only one class and the property voting and other rights and privileges and/or liability, dues or assessments, the method of collection thereof shall be uniform and for the use and benefit of this non-profit Corporation only.

The Board of Directors may authorize the issuance of membership certificates which shall have no par value, but shall be evidence of participation herein.

ARTICLE VI.

That the By-Laws of the Corporation shall be adopted by the Directors named in the Articles of the Corporation, or a majority thereof, and may thereafter be amended or repealed by any means provided in the By-Laws.
