ARTICLES OF INCORPORATION.

TELLER PUBLISHING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, a majority of whom are citizens and residents of the State of Idahe, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idahe.

AND WE HERBEY CERTIFY.

First, That the name of the corporation shall be the TELLER PUBLISHING COMPANY, LIMITED.

Second, That the purposes for which it is formed are as follows, towit:

- (a) To edit, publish and print a newspaper of general circulation.
 - (b) To sarry on and conduct a general newspaper business.
- (c) To do general and job printing, lithographing, and such other kind of work as is usually done in a general job printing office.
- (d) To purchase, acquire, own, held, mortgage or sell materials, machinery, furniture, fixtures and appurtenances for earry ing on a newspaper and job printing business.
 - (e) To contract for news and telegraphic reports.
- (f) To buy, sell, asquire, own, held, mortgage and hypethecate real and personal property for the condust and eperation of a newspaper and job printing business.
- (g) To make and enter into contracts of every kind and nature with any individual, firm, association, corporation, private, public or municipal.
 - (h) Also to take and acquire by purchase, exchange or

other lawful modes, and to hold, own, sell and otherwise dispose of the capital stock and bonds of other corporations.

(1) To do all and everything necessary, suitable and proper, for the accomplishment of any of the purposes, or attainment of anyone or more of the objects herein enumerated, or which shall at any time appear conducive or expedient for the protection of benefit of the corporation.
