

ARTICLES OF INCORPORATION,
OF THE
TELLER PUBLISHING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, a majority of whom are citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho.

AND WE HEREBY CERTIFY,

First, That the name of the corporation shall be the TELLER PUBLISHING COMPANY, LIMITED.

Second, That the purposes for which it is formed are as follows, to-wit:

- (a) To edit, publish and print a newspaper of general circulation.
- (b) To carry on and conduct a general newspaper business.
- (c) To do general and job printing, lithographing, and such other kind of work as is usually done in a general job printing office.
- (d) To purchase, acquire, own, hold, mortgage or sell materials, machinery, furniture, fixtures and appurtenances for carrying on a newspaper and job printing business.
- (e) To contract for news and telegraphic reports.
- (f) To buy, sell, acquire, own, hold, mortgage and hypothecate real and personal property for the conduct and operation of a newspaper and job printing business.
- (g) To make and enter into contracts of every kind and nature with any individual, firm, association, corporation, private, public or municipal.
- (h) Also to take and acquire by purchase, exchange or

other lawful modes, and to hold, own, sell and otherwise dispose of the capital stock and bonds of other corporations.

(1) To do all and everything necessary, suitable and proper, for the accomplishment of any of the purposes, or attainment of anyone or more of the objects herein enumerated, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation.

Third, That the place where the principal business of said corporation is to be transacted is Lewiston, Idaho.

Fourth, That the term for which said corporation is to exist is fifty (50) years from and after the date of its incorporation.

Fifth, That the number of directors or trustees of said corporation shall be five, and that the names and residences of the directors or trustees, who are appointed for the first year and to serve until the election and qualification of such officers are as follows, to-wit:

Sixth, That the amount of capital stock of the said corporation is Twenty-five Thousand (\$25,000) Dollars, and number of shares into which it is divided is Twenty-five Thousand (25,000) of the par value of One (\$1.00) Dollar each.

Seventh, That the amount of said capital stock which has actually been subscribed is Ten Thousand (\$10,000) Dollars,
