## ARTICLES OF AMENDMENT

OF

## LA MONTAGNE VINEYARDS, INC.

We, the undersigned duly elected and qualified officers of La Montagne Vineyards, Inc., an Idaho corporation, respectfully represent as follows:

I.

That after due and proper notice in accordance with Section 30-146 (6) of the Idaho Code a meeting of the shareholders was had at the corporation's office at 7:00 p.m. on the 24th day of June, 1974, with all of the shareholders being present based upon the notice and purpose of the meeting.

II.

That the purpose of said meeting was to change the stock structure of the corporation to provide as follows: That in addition to the articles of amendment approved, filed and admitted on the 20th day of March, 1974, the authorized issue of stock be increased by the amount of \$850,000.00 consisting of 8,500 shares of preferred stock of the value of \$100.00 per share, rendering the total authorized issue of stock to be \$1,050,000.00.

III.

That at said meeting duly called and conducted by proper notice the measure was fully considered and discussed and unanimously adopted by the stockholders of said corporation.

IV.

Now, therefore, paragraph VI of the original Articles of Incorporation should read as follows by the action of the stockholders of said corporation and this amendment thereto:

"That the total authorized amount of capital stock of said corporation shall be \$200,000.00 divided into 20,000 shares of common stock of the par value of \$10.00 each and the further authorized issue of stock be increased by the amount of \$850,000.00 consisting of 8,500 shares of preferred stock of the value of \$100.00 per share, rendering the total authorized issue of stock to be \$1,050,000.00.
