The undersigned, acting as incorporator under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I.

#### NAME OF THE CORPORATION

#### ARTICLE VII.

#### DIRECTOR LIABILITY

No amendment to or repeal of this Article VII shall apply to or have any effect on the liability or alleged liability of any Director of the Corporation for or with respect to any acts or omissions of such Director occurring prior to the effective date of such amendment or repeal.

#### ARTICLE VIII.

#### **INDEMNIFICATION**

Each person who is or was or had agreed to become a Director, officer, employee or agent of the Corporation (including the heirs, executors, administrators or estate of such person), shall be indemnified by the Corporation to the full extent permitted by the Idaho Business Corporation Act or any other applicable laws presently or hereafter in effect. Without limiting the generality or effect of the foregoing, the Corporation may enter into one or more agreements with any person which provide for indemnification greater or different than that provided in this Article VIII. No amendment to or repeal of this Article VIII shall apply to or have any effect on the right to indemnification permitted or authorized hereunder for or with respect to any acts or omissions of such Director, officer, employee or agent occurring prior to the effective date of such amendment or repeal.
