### ARTICLES OF AMENDMENT

The corporation not having members entitled to vote until after the following amendments were enacted, the board of directors met on August 25, 1992, with four of the five directors present, and adopted the following amendments, each of which was carried unanimously. The provisions are hereby amended to read:

# ARTICLE FOUR

3. To provide cultural education and entertainment for the general public by developing a summer music festival to be held at Elkhorn Resort at Sun Valley, Idaho or any other location in Blaine County, Idaho, in a relaxed and naturally beautiful atmosphere conducive to the performance and enjoyment of quality classical music.

### ARTICLE SIX

The location of the registered office of the corporation is 110 Grey Eagle, Sun Valley, Idaho 83353; the name of the registered agent is Robert Atkinson; the mailing address of the corporate agent is P. O. Box 1929, Sun Valley, Idaho 83353.

## ARTICLE NINE

The directors shall be elected at the annual meeting of the members of the corporation, or at a special meeting called for such purposes, for terms of one (1) year, or such longer period as the board may determine, not to exceed three (3) years, and they shall hold office until their successors are duly elected and qualified.
