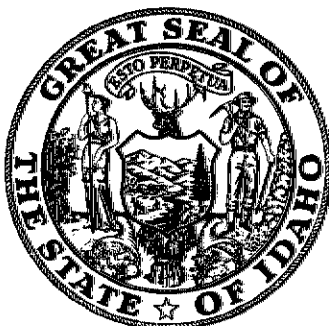

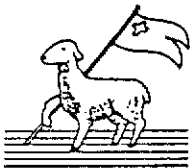

1. a. The name of this non-profit organization shall be Lamb of God Lutheran Church, Incorporated.
 - b. Lamb of God Lutheran Church exists for the purpose of preaching and teaching the Gospel of Jesus Christ.

2. a.i,ii. Affairs of this organization are regulated in the following manner:
 - Doctrinal matters are determined by the Bible and the teachings of the Lutheran Church
 - Administrative and practical matters are determined by the congregation through its Board of Directors.
