KNOW ALL MEN BY THESE PRESENTS. That We, the undersigned, have this day Voluntarily Associated Ourselves together for the purpose of forming a Corporation, under the Laws of the State of Idaho.

AND WE HEREBY CERTIFY:

First.

That the Name of said Corporation is " THE WOOLGROWERS STORAGE & FORWARDING COMPANY. (Limited.) "

Second.

The purposes for which it is formed are TO STORE WOOL AND OTHER MERCHANDISE TO OWN, Sell, Handle, Forward, Consign, Lease, Mortgage, Rent and Dispose of the same or any part thereof, To hold, own, Lease, Rent, Mortgage, and Sell sufficient Real Estate, Houses and Buildings, to carry on the business hereof, to do a general Ware House and Forwarding Business, and to do and perform each and every thing necessary for the purpose of conducting the business fully and completely in every respect.

Third.

That the place where its principal Business is to be transacted shall be at the City of Weiser, in Washington County State of Idaho.

Fourth.

That the term for which it is to exist is Fifty Years from and after the date of its Incorporation.

Fifth.

That the Number of its Directors shall be Five, and that the names and Residences of these who are appointed for the first year are:


