THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

ARTICLE I.

The name of the corporation shall be: DeWayne Farms, Inc.

ARTICLE II.

The Corporation is formed for the following purposes:

For dairy and row crop farming, including, but not

limited to, the production of milk from cows and its sale,

the raising of crops for human or animal consumption and

utilization, the raising and sale of livestock, and all

matters incident thereto.

For the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq.

ARTICLE III.

The Corporation is authorized to issue one class of shares, in a total amount of 100 shares, each share of stock bearing a par value of \$60.00. Shares of stock of this Corporation shall not be transferred or sold until said

The Capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.
