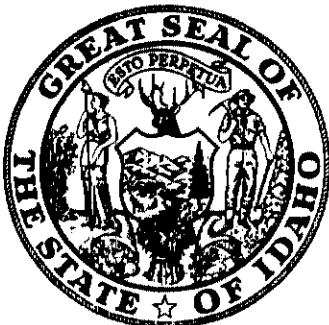

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, being of full legal age and a citizen of the United States, does this day voluntarily petition for the formation of a nonprofit corporation under the laws of the state of Idaho, and hereby adopts Articles of Incorporation as follows:

I

The name of the corporation shall be PEND OREILLE LAKE TO FOREST TRIATHLON CORPORATION.

II

The period and duration of the corporation shall be perpetual.

III

The purpose of the corporation shall be to engage in any lawful activity.

IV

The corporation shall be managed by a board of three directors. The initial board shall consist of the following individuals:

VI

The sole incorporator of this corporation shall be Mark DeLaVergne, 815 Poplar Street, Sandpoint, Idaho 83864.

The corporation shall have members.

VIII

Upon dissolution, the assets of the corporation shall be distributed first in accordance with the provisions of Idaho Code 30-3-114 and 30-3-115, then to one or more entities described in 501(c)(3) of the Internal Revenue Code.


