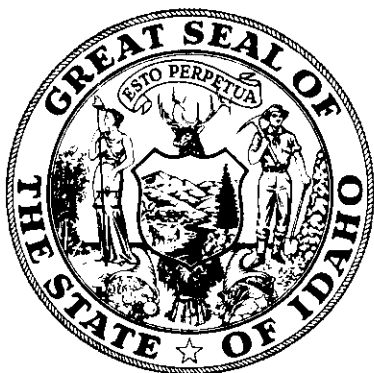

ARTICLES OF INCORPORATION OF
POST FALLS VOLUNTEER FIRE FIGHTERS, INC.

WE, THE UNDERSIGNED, desiring to form a non-profit corporation in accordance with the provisions of Chapter 3, Title 30, of the Idaho Code, otherwise known as the Idaho Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the Corporation shall be POST FALLS VOLUNTEER FIRE FIGHTERS, INC.

ARTICLE II

The Corporation is not organized for pecuniary profit or gain.

ARTICLE III

The duration of this Corporation shall be perpetual.

ARTICLE IV

This Corporation is organized for the purpose of protecting life and health, promoting safety, fighting fires, providing training and disseminating information all to benefit the public health, safety and welfare of the community within which this Corporation is formed.

ARTICLE V

The Corporation shall have members, all of whom shall be of one class. The Corporation shall not issue certificates, shares of stock, cards, or other instruments evidencing membership rights or voting rights. The manner of election or appointment

of members and the qualifications and rights of members shall be set forth and established by the Bylaws of the Corporation.

ARTICLE VI

The management of the Corporation shall be vested in a Board of Directors which shall consist of not less than three (3) nor more than seven (7) Directors. The initial Board of Directors shall consist of seven (7) Directors.

ARTICLE VII
