The undersigned, all of whom are duly licensed to practice the profession of certified public accountants in the State of Idaho, do hereby form a professional corporation, pursuant to the provisions of I.C. Sections 30-1301, et seq, the Idaho Professional Corporation Act, for the purpose of rendering certified public accounting services, and hereby adopt the following articles of incorporation:

ARTICLE I.
