ARTICLES OF INCORPORATION OF
 HUNTER'S GLEN HOMEOWNERS' ASSOCIATION, INC. SECRETARY OF STATE
 (A NON-PROFIT CORPORATION) STATE OF IDAHO

THE UNDERSIGNED, acting as incorporator of a non-profit corporation under the Idaho

Non-Profit Corporation Act, Idaho Code §30-3-1, et seq., adopts the following Articles of Incorporation.

ARTICLE I.

The name of the corporation is Hunter's Glen Homeowners' Association, Inc. The corporation is a non-profit corporation.

ARTICLE II.

The period of the corporation's duration is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are to transact any and all lawful business for which corporations may be incorporated under the Idaho Non-Profit Corporation Act, including the governance and enforcement of and under that certain "Declaration of Covenants, Conditions, Restrictions and Reservations of Easement for Hunter's Glen Subdivision, Phases 1 and 2, Located in Post Falls, Kootenai County, Idaho" (recorded January 26, 2001 as Kootenai County Instrument No. 1663677), and any amendments thereto. The affairs of the corporation shall be managed by its Board of Directors.

ARTICLE IV.

ARTICLE V.

The number of directors constituting the initial Board of Directors of the Corporation is three (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the members or until their successors are elected and shall qualify are: Tom Anderl, 3901 Schreiber Way, Coeur d'Alene, ID 83814; Fred Sharp, Jr., 3901 Schreiber Way, Coeur d'Alene, ID 83814; and David Gorringer, 3901 Schreiber Way, Coeur d'Alene, ID 83814.

The name and address of each incorporator is as follows: Tom Anderl, President, Shorewood Homes, Inc., 3901 Schreiber Way, Coeur d'Alene, ID 83814.

ARTICLE VI.

In the event the corporation is dissolved in conformity with both Idaho law (the Idaho Non-Profit Corporation Act, I.C. §30-3-1, et seq., as it now exists or is hereafter amended) and the provisions of Kootenai County Instrument No. 1663677, then any assets of the Corporation which remain after paying all corporate obligations and liabilities shall be liquidated and distributed to the Corporation's members (to be determined as of such date as the Corporation's Board fixes in its discretion) pro rata.

ARTICLE VII.

Membership in the Association is as defined in Article II of the "Declaration and Establishment of Covenants, Conditions, Restrictions and Reservations of Easements for Hunter's Glen Subdivision, Phases 1 and 2, Located in Post Falls, Kootenai County, Idaho," recorded as Kootenai County Instrument No. 1663677 on January 26, 2001, and any

subsequent amendments thereto. Proof of ownership of a lot described in, and subject to, the referenced Declaration shall constitute sufficient proof of membership in the corporation.

ARTICLE VIII.

Authorization of assessments to be levied upon all members of the corporation are herein granted. The Board of Directors are herein authorized to fix the amount and collection of assessments by such methods as are provided in, and consistent with, the subject Declaration. Assessments are enforceable by legal action as provided in the subject Declaration.

ARTICLE IX.

All voting members, as defined in the subject Declaration, shall enjoy the right of cumulative voting in any election for directors of the corporation.


