Any person shall be admitted as a member of the Corporation upon payment of the annual dues set by the

before that date such person has paid the annual dues established for the calendar year in procedures for  
the suspension or termination of a membership by the Corporation may be established from time to time by  
the Board of Directors and recorded in the minutes of the proceedings of the Board of Directors.
