- III. The duration of this corporation is perpetual.
- IV. The purpose of the corporation is as follows:
 - A. To operate places of Christian worship and education
 - B. To produce and distribute Christian material and literature for the purpose of education, encouragement and enrichment of the community and family
 - C. To promote, operate or otherwise provide for christian missions, both domestic and foreign
 - D. To educate, train, licensce and ordain Christian Ministeries and Ministers
- V. The non-profit corporation is to have a non-voting membership. The name and address is: The Winepress Christian Fellowship and Ministries, Inc., 312 Meadows Lane, Twin Falls, Idaho.
 - A. The governing body of Senior Ministry and, Elders and deacons has the authority to elect-trustees and officers and appoint, committees, conferences or councils as needed.
 - B. The governing body of the Senior Ministry, Elders and Deacons retains unto itself exclusive right of Self Government in all phases of the spiritual and temporal life of the ministry and church.
 - C. The Senior Ministry has veto puragative on all matters.
- VI. Discipline: It shall be the practice of this ministry and its churches, fellowships and missions to conduct its business and resolve troubles by the application of the Holy Scriptures as represented in the Old and New Testaments of the Bible. Should some situation exsist that by the conduct of any member or leader, harm to the organization or its members or the cause of Christ may result or has resulted, or by that conduct or action violate biblical principles every effort shall be made to

Should restoration thru repentance, confession, restitution or other appropriate biblical means prove unattainable, exclusion from the ministry, its churches, fellowships or missions may result, with the door of restoration remaining open.
