The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

Name. The name of the corporation is **SELWAY MANAGEMENT CORPORATION.**

ARTICLE TWO

Duration. The period of duration of the corporation is perpetual.

ARTICLE THREE

Purposes. The purposes of the corporation are to operate as an automobile, truck and trailer dealer. To buy and sell used and new equipment; to buy and sell both real and personal property; and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE FOUR

Stock and Par Value. The aggregate number of shares which the corporation shall have authority to issue, which shall consist of one class only, shall be one thousand (1000) shares,

the par value of each of such shares shall be One Hundred Dollars (\$100.00).

ARTICLE FIVE
