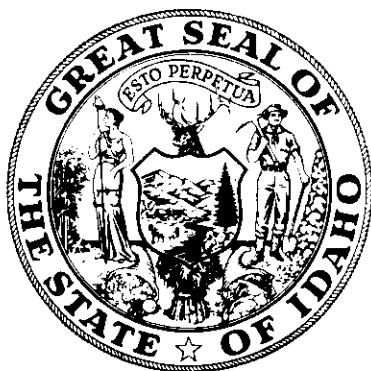

ARTICLES OF INCORPORATION
OF
VERN'S IMPORT AND SMALL CAR REPAIR, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is VERN'S IMPORT AND SMALL CAR REPAIR, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which the corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock having a par value of \$10.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are set forth in the By-Laws.

SEVENTH: The address of the initial registered office of the corporation and the name of its initial registered agent at such address is Vern L. Johnson, 796 East Iona Road, Idaho Falls, Idaho 83401.






