

ARTICLES OF INCORPORATION

OF THE

West Branch Canal Company

Know All Men by These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho

And We Hereby Certify,

First: That the name of said Corporation is The West Branch Canal Company

Second: That the purposes for which it is formed, are to construct and maintain the western branch Canal of what is known as the Blackfoot Irrigation Company, for irrigation domestic and manufacturing uses,

Third: That the Capital Stock shall be Ten Thousand Dollars divided into 200 shares of Fifty Dollars each.

Fourth: That the place where its principal business is to be transacted shall be Blackfoot Bingham County, Idaho.

Fifth: That the term for which it is to exist is fifty years from and after the date of its Incorporation.

Sixth: That the number of its Directors or Trustees shall be Seven and that the names and residences of those who are appointed for the first year are:
