ARTICLES OF INCORPORATION

FILED/EFFECTIVE JOHNSON FAMILY RECREATION, INC.

The undersigned, acting as the incorporators of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation ("Articles").

ARTICLE I - Name

The name of the Corporation is the JOHNSON FAMILY RECREATION, INC.

ARTICLE II - Nonprofit Status

The Corporation is a nonprofit corporation.

ARTICLE III - Duration

The duration of the corporation shall be perpetual.

ARTICLE IV - Registered Office and Agent

The location of the Corporation is in the City of Victor, County of Teton, State of Idaho. The address of the initial registered office is: 152 West 800 South, Victor, Idaho, 83455, and the name of the initial registered agent at this address is Terry Johnson.

ARTICLE V - Purposes

The purposes for which the Corporation is organized and will be operated are as follows:

- A. To promote activities designed to unite the family and preserve the memory and ideals of Eldon and Velda Johnson.
- The corporation may do all things as fully and to the same extent as natural B. persons might or could do, viz; acquire, purchase, own, hold, operate,

- develop, lease, mortgage, pledge, exchange, sell, transfer, invest, trade, or otherwise deal in real or personal property, stocks, bonds, and securities.
- C. The corporation shall have and exercise all powers necessary or incident to carrying out its corporate purposes. The corporation shall exercise all powers permitted by law and possess and enjoy all rights and powers which now or at any time hereafter may be granted to or exercised by this corporation under the laws of Idaho.

ARTICLE VI - Section 501(C)(3) Limitations

No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

ARTICLE VII - Members

A. The Corporation shall have members who shall have such rights as are provided in the Act and are consistent with the management authority that these articles grant the Board of Directors of the Corporation. Any person may become a member of the Corporation upon election to the Board of Directors.

ARTICLE VIII - Board of Directors

The affairs of the Corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation's Bylaws. The qualifications of persons to become directors of the corporation shall be set forth in the bylaws. Other than the Directors constituting the initial Board of Directors who are designated in these Articles, the Directors shall be elected by the existing Directors of the Corporation in the manner and for the term provided in the Bylaws of the Corporation. The affairs of the Corporation will be exercised by the officers of said Corporation and at a later time be ratified by a majority of the directors. No director shall have any pre-emptive right. Each Director shall have one vote.
