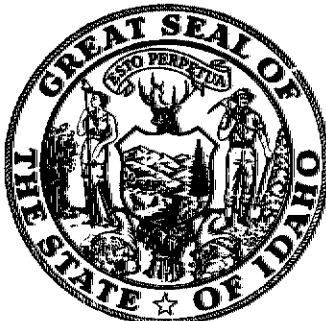

ARTICLES OF INCORPORATION

OF

SHORTCUTS CONSTRUCTION, INCORPORATED

We, the undersigned, natural persons of the age of twenty-one years or more, acting as incorporators under the Idaho General Business Corporations Act, adopt the following Articles of incorporation.

ARTICLE I - NAME

The name of this Corporation is **SHORTCUTS CONSTRUCTION, INCORPORATED.**

ARTICLE II - DURATION

The duration of this Corporation is perpetual.
