ARTICLES OF INCORPORATION

OF

NORTH IDAHO ENERGY LOGS, INCORPORATED

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation shall be "NORTH IDAHO ENERGY LOGS, INCORPO-RATED." The corporation may from time to time use the abbreviation "INC." in its name in place of the word "INCORPORATED" to denote that it is a corporation.

ARTICLE TWO

PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE THREE

CORPORATE PURPOSES

The purpose for which the corporation is organized shall be any or all lawful purposes and business for which a corporation may be incorporated under the Idaho Business Corporation Act and the laws of the State of Idaho.

ARTICLE FOUR

AUTHORIZED SHARES OF STOCK

The aggregate number of shares of corporate stock which the corporation shall have authority to issue shall be Twenty Thousand (20,000) shares. All of such shares of corporate stock shall have a par value of One (\$1.00) dollar per share.

ARTICLE FIVE

NO PREEMPTIVE RIGHTS

There shall be no provisions granting preemptive rights to any class of stock or any stockholder.

ARTICLE SIX

BYLAWS REGULATE INTERNAL AFFAIRS

Provisions for the regulation of the internal affairs of the organization shall be set forth in the Bylaws of the corporation.

ARTICLE SEVEN

REGISTERED OFFICE AND AGENT
