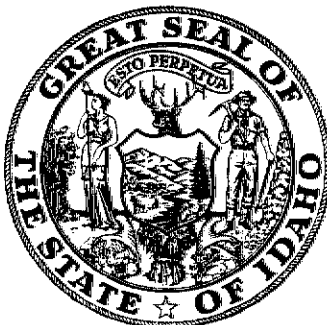

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation² Act, adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is Communication Quest, Inc.

ARTICLE II

The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act. Further, to engage in the business of providing computer services, marketing, retailing, internet presence and related services and products.

ARTICLE III

The period of duration of the corporation is perpetual.

ARTICLE IV

The address of the corporation's initial registered office in the State of Idaho is (1425 Uniontown Road) Box 41, Genesee, Idaho 83832. The name of the corporation's initial registered agent at such address is Donald Skyler Schlueter.

ARTICLE V

The total authorized number of par value shares of stock is 100,000 shares having a par value of \$.50 per share. The aggregate par value of the total authorized number of par value shares is

FIFTY THOUSAND and NO/100 DOLLARS (\$50,000.00). The total authorized number of shares without par value is none. All stock of the corporation shall be common stock.

ARTICLE VI

Pursuant to Idaho Code 30-1-26, the shareholders shall have the preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares. The provisions of Idaho Code 30-1-26 as amended from time to time shall be controlling with respect to preemptive rights of shareholders.

ARTICLE VII

The number of directors constituting the initial board of directors is two (2) and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:



