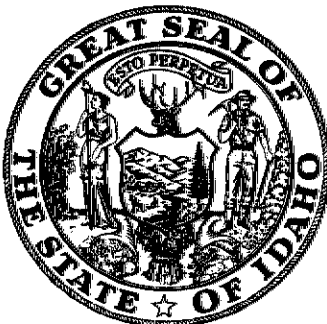

Pursuant to Idaho Code §30-3-91, et seq, the Articles of Incorporation of Lost Lake Ridge Property Owners Association, Inc., an Idaho non-profit corporation, filed September 18, 1995 with the Office of Secretary of State, State of Idaho, are herein amended.

In compliance with law, the directors recite the following:

1. The present Board of Directors consist of three (3) members, consisting of George H. DeKay, IV, Ann Jost DeKay, and Malcolm Yuill-Thornton. At a special meeting of the Board of Directors held on October 31, 1995, after notice was duly given or waived, the Directors unanimously approved the changes set forth in these Articles of Amendment.

2. The eight members of the Association (8 property owners listed by Tract Number)) consist of the following:

George H. DeKay, IV, Ann Jost DeKay, and Malcolm Yuill-Thornton, and Michael E. Gill and Constance J. Gill, own more than 2/3rds of the Tracts (majority of the voting power), and consent to the amendments herein.

3. The original Articles of Incorporation of the corporation do not require special approval of any other party.

The Articles of Incorporation are herein amended to add an additional Article (Article 8), which states the following:

ARTICLE VIII

The assessments levied by the Association, pursuant to Article

ARTICLES OF AMENDMENT: 1

IV of the Articles of Incorporation, shall be subordinate to the lien of a first Mortgage or first Deed of Trust on any of the properties described in the Articles of Incorporation.

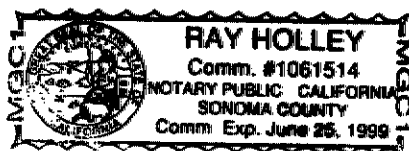

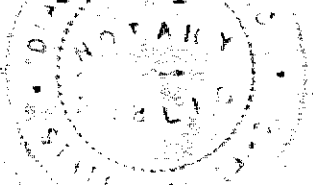
