ARTICLES OF INCORPORATION

OF

THE SPORTSMAN, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, Harold L. Carraway, Estelle L. Carraway, Ralph L. Langford and June Langford, being of full age and citizens of the United States of America, and actual and bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

First: That the name of the corporation shall be

THE SPORTSMAN, INC.

Second: That the purposes for which said corporation is formed are:

- (a) To run a general sporting goods and hobby store.
- (b) To conduct a general repair business for repairing sporting goods, appliances and other equipment used in connection with hobbies.
- (c) To borrow money and to issue notes, mortgages and other debentures therefor, and to mortgage, pledge, hypothecate or convey in trust any or all of its property to secure the payment thereof.
- (d) To purchase, improve, develop, lease, exchange, sell dispose of, and otherwise deal in and turn to account real estate in connection with the above purposes.
- (e) To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers, which a co-partner or natural person could do or exercise, and which now or hereafter may be authorized by law.

Third: That the term of this corporation shall be perpetual.

Fourth: That the Board of Directors shall consist of Four (4) persons.

Fifth: That the registered office of the corporation shall be located at Rupert, Minidoka County, Idaho.

Sixth: The capital stock of the corporation shall be two hundred fifty (250) shares of no-par value stock.

Seventh: The capital stock of the corporation which has actually be subscribed is fifty (50) shares, and the following are the names, post office addresses and shares:




