

CERTIFICATE OF AMENDMENT

OF

CERTIFICATE OF INCORPORATION

Automatic Canteen Company of America, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That at a meeting of the Board of Directors of Automatic Canteen Company of America resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and directing that said amendment be submitted to the next annual meeting of the stockholders of said corporation for consideration thereof. The resolution setting torth the proposed amendment is as follows:

RESOLVED, that it is hereby proposed and declared to be advisable that the Certificate of Incorporation of the corporation, as previously amended, be amended to change the name of the corporation from Automatic Canteen Company of America to Canteen Corporation; and that for the purposes of carrying out the aforesaid change, Article First of said Certificate of Incorporation, as previously amended, is amended so as to read as follows:

FIRST. The name of the corporation is

CANTEEN CORPORATION

FURTHER RESOLVED, that, pursuant to Section 242 of the Delaware General Corporation Law, the foregoing proposed amendment to the Certificate of Incorporation be submitted to the next annual meeting of stockholders of the corporation to be held February 15, 1966 for adoption by the corporation's stockholders.

FURTHER RESOLVED, that, if the stockholders of the corporation adopt the proposed amendment to the Certificate of Incorporation, the proper officers of this corporation be and they hereby are authorized to file a certificate of amendment with the Secretary of the State of Delaware and a certified copy thereof in the Office of the Recorder of New Castle County, Delaware.

SECOND: That thereafter, pursuant to resolution of its Board of Directors, the amendment was submitted to the next annual meeting of the stockholders of said corporation, which was duly called and held and at which meeting the necessary number of shares as required by statute were voted in favor of the amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
