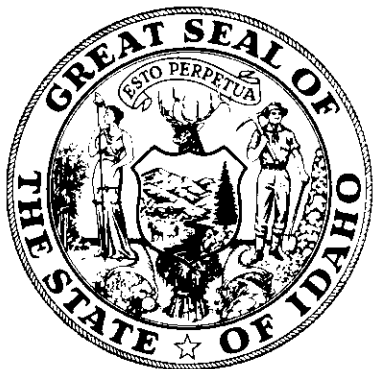

FIRST: The name of the Corporation shall be VAN KOMEN, CHARTERED.

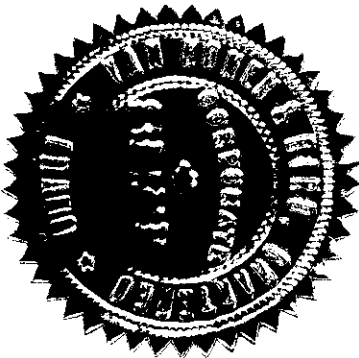
