

I, the undersigned, being an adult citizen of the United States of America, do hereby form a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE II

The name of this Corporation shall be "Steeley Print and Binding, Inc.

ARTICLE I

The term of existence of this Corporation shall be perpetual.

ARTICLE III

The purposes for which this Corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue is one hundred thousand, (100,000); the shares shall consist of one (1) class only; the par value of each share shall be the sum of ten dollars, (\$10.00); the total

authorized capital stock of the corporation is the sum of one million dollars, (\$1,000,000). The stock of this Corporation shall be nonassessable.

ARTICLE V

The address of the initial registered office of the corporation is 201 C Street, Lewiston, Idaho 83501. The name of the initial registered agent of the corporation at the initial registered office of the corporation is Betty L. Steeley. The mailing address is 201 C Street, Lewiston, Idaho 83501.

ARTICLE VI

The corporation shall have two, (2) directors, except in the event that all of the shares of the corporation are owned beneficially and of record by fewer than two, (2) shareholders, in which event the number of directors may be fewer than two, (2) but not fewer than the number of shareholders.

The initial board of directors shall consist of two, (2) directors. The names and addresses of the persons who are to serve as the directors until their successors be elected and qualified are:
