ARTICLES OF INCORPORATION

ARTICLE I
NAME

these Articles of Incorporation is vested in the Board of Directors of the Corporation.


ARTICLE IX LIMITED DIRECTOR LIABILITY

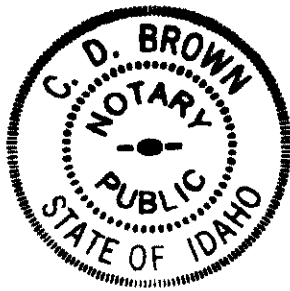
