# ARTICLES OF INCORPORATION of RICHFIELD COMMUNITY CHURCH, Inc.

We, the undersigned persons, acting as the incorporators of a nonprofit corporation under the provisions of the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be Richfield Community Church, Inc.

ARTICLE II

The period of duration of the corporation shall be perpetual.

#### **ARTICLE III**

The corporation is organized exclusively for educational, charitable, and religious purposes within the meaning of Section 501© (3) of the Internal Revenue Code. Consistent with and subject to its qualification under Section 501 © (3), the corporation is organized to do any lawful activity permitted under the laws of the State of Idaho.

#### **ARTICLE**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, EXCEPT THAT the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the corporation. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publishing or distributing of statements0 any political campaign on behalf of a candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code, as now stated, deductible under Section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code.

# **ARTICLE V**

The corporation shall have all powers granted by law necessary and proper to carry out its above-stated purposes, consistent with its qualification under Section 501(c) (3).

#### **ARTICLE VI**

Provisions for the regulation of the internal affairs of the corporation shall be set forth in the constitution and bylaws.

In the event that the Southern Idaho District Council of the Assemblies of God does not so qualify, then the assets of this corporation shall be distributed to the General Council of the Assemblies of God, provided it qualified at such time for exemption as an organization described in Section 501(c) (3) of the Internal Revenue Code or a successor statute.
