BE IT KNOWN, That we, whose names are hereto subscribed, do, under and by virtue of the laws of the State of Idaho, hereby organize, constitute and associate ourselves and such other persons as may hereafter become associated with us, into a body corporate and politic, and to that end, execute this instrument, which, when certified, filed and recorded as by law required, shall constitute the Articles of Incorporation of the Bank of Commerce Payette, Limited, and by them, we declare:

First: The name of this corporation is the Bank of Commerce Payette, Limited.

The purposes for which it is formed and its powers under Second: its corporate name and organization, are to conduct and do a general banking business, to buy, sell and issue foreign and domestic bills & of exchange, to receive money on deposit, to loan money, to charge and receive interest on loans, to issue certificates of deposit, to buy, sell, own, receive in pledge, or pledge, handle, deal in or hypothecate all kinds of commercial and negotiable paper, sureties, bonds, notes, mortgages, deeds of trust and stocks of all kinds, stocks and bonds of other corporations, bank notes and all other evidences of indebtedness or liability and to make loans or advances on the same; or to act as agent, attorney or trustee or in any other fiduciary capacity in the sale, transfer, handling or disposition of any of the aforesaid evidence of indebtedness or obligations or securities, or as the agent, attorney, trustee or in any other fiduciary relation or capacity, in loaning money on the same, or to act as the grantor or surety for corporations or individuals and to accept and execute trusts and in its corporate capacity, or by or through its agent, officers or attorneys, to deal in, buy and sell all classes of obligations, bonds, warrants, due bills, certificates or other evidences of indebtedness, issued by private or public corporations, states, counties, school districts municipalities, towns, villages, water or irrigation districts, and any of the subdivissions or parts of said political orginizations, that are lawfully created or that now lawfully exists; and to act as agent for others in the purchase and sale thereof; To act as trustee, assignee, Receiver, guardian, conservator, executor and administrator; to take entire charge of estates and the settlement thereof; To purchase, bond, lease, sell, convey, manage or incumber & such realty as the corporation may acquire, to take possession of and to bond, lease, sell, convey, mortgage, or pledge such other property, either real or personal, as may be taken on debts due the corporation, to loan money on realty or personal property; to own and manage such corporation, or to organize, own and manage such branches of banking, loan, trust, guaranty or security business as are or may properly be connected with the general purposes of the corporation as herein set forth, and generally to do all of the things incident to or connected with a general banking business.
