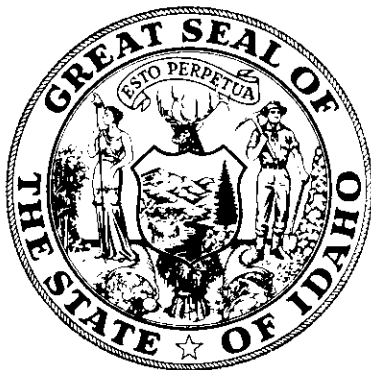

Pursuant to the provisions of Sections 30-1-59 and 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is GROUP INVESTMENTS, LTD.

SECOND: By consent dated Feb. 28, 1991, the corporation's sole shareholder adopted and approved the following amendment to the Articles of Incorporation of Group Investments, Ltd., pursuant to which the existing Article I is deleted and a new Article I is added to the original Articles of Incorporation of Group Investments, Ltd. as filed on March 11, 1982:

"I.

The name of the corporation is COMMERCIAL PROPERTY
MANAGEMENT, INC."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 7600; and the number of shares entitled to vote thereon was 7600.
