ARTICLES OF INCORPORATION OF STATE

KNOW ALL MEN BY THESE PRESENTS:

WE, THE UNDERSIGNED, DUANE E. KEARN, JAMES B. HEBERLEIN, MICHAEL J. HEBERLEIN, KENNETH L. MALAND, ROBERT G. RISO, DAVID W. HEBERLEIN AND JAMES E. HEBERLEIN, each being at least twenty-one (21) years of age and residents of the State of Idaho, and all being citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, do, under and by virtue of the general laws of the State of Idaho authorizing the formation of corporation, associate ourselves as incorporators with the intention of forming a corporation and do hereby certify as follows:

Ī.

The registered name of the corporation shall be: QUADCON CORPORATION

II.

The purposes for which this corporation is formed are:

- (a) To purchase, buy, sell, use, improve or otherwise own real estate for the purpose of the development and construction of such real estate.
- (b) To hold, own and to acquire for certificates of convenience of necessity, licenses and franchises from state, city, county or federal agencies as required in the furtherance of the corporation's business.
- (c) In general, to carry on any other lawful busines whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation and to enhance the form of its properties and to do all other things necessary for the protection or the benefit of the corporation.

The corporation is to have perpetual existence.

The total authorized number of par value shares is 10,000 shares. It shall have \$1.00 par value per share. The 10,000 shares shall be identified as Common Voting Stock at \$1.00.
