FOURTH: This Corporation is formed for religious, educational and charitable purposes, to wit, financing the acquisition of sites and the acquisition of sites and the erection of facilities to aid expansion for effective programs of ministry, witness, outreach, and service, and, in so doing, is organized to:

- b. aid in motivating individuals, congregations and organizations in acquiring investments for loan fund use in a systemic manner.
- c. provide leadership in advance site acquisition for further expansion.
