ARTICLES OF INCORPORATION

OF
KCS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being citizens of the United States of America, and of the State of Idaho, and being over twenty-one years of age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and to that end do hereby adopt Articles of Incorporation, as follows:

1. The name of said corporation shall be KCS, Inc.

2. The purposes of the corporation are as follows: To buy, sell, mortgage, lease, develop and otherwise deal in land, and to deal as necessary in chattels incidental to land development; to buy, sell, build, lease, mortgage and otherwise deal in homes, offices, apartments and commercial buildings; to buy, sell, lease, own or operate or otherwise deal in recreational facilities; to extend credit, to borrow money and to do any other thing reasonably necessary or intended to promote the primary objects of this corporation, together with such other powers and purposes not inconsistent herewith as are usually had and exercised or as may be needful to the proper conduct of any business.

3. The duration of said corporation shall be perpetual.

4. The location and post office address of the registered office of said corporation is: Soda Springs, Idaho.

5. The capital stock of said corporation shall consist of 10,000 shares of common stock for a par value of \$5.00 per share, the total proposed capitalization of said corporation being \$50,000.00.

6. The name and post office address of each of the incorporators and the number of shares of stock for which each has subscribed is as follows:
