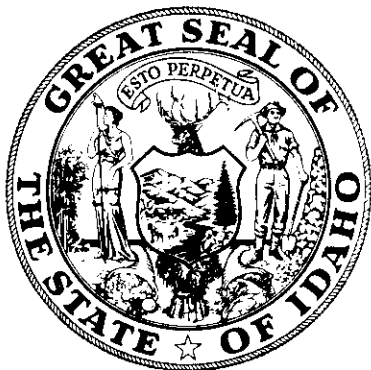

ARTICLES OF INCORPORATION OF
PRICE AND STREETER, CPA's, P.A.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned are the duly elected President and Secretary of the above-named corporation, and hereby certify in accordance with the provisions of the Idaho Business Corporation Act and the Idaho Professional Service Corporation Act, that at a special meeting of all stockholders and directors of said corporation held on the 19 day of October, 1990, that said stockholders and directors by unanimous vote adopted an Amendment to the Articles of Incorporation of Price and Streeter, CPA's, P.A. by amending Article I thereof to read: "Name: The name of said Corporation shall be Garald E. Price, CPA, P.A." By resolution, said Amendment is effective November 1, 1990. The sole stockholder of the corporation, Garald E. Price, exercised his ballot by voting 80 shares of common par value \$1.00 stock in favor of such Amendment. All such shares were entitled to vote. Said resolution was duly passed by said stockholder on the 19 day of October, 1990.
