AMENDMENT OF LIMITED PARTNERSHIP CERTIFICATE

1. The name of the Limited Partnership is the McINTOSH & SONS LIMITED PARTNERSHIP.

2. The date of filing of this Certificate is February 27<sup>th</sup>, 1985.

3. Pursuant to the provisions of the Limited Partnership Agreement, all of the general partners have given written consent to the admission of NANCY JOHNSTON, JUDY NEWBOLD, KATHERINE ANN McINTOSH and MARY MICHELLE McINTOSH, as limited partners. Each of the new limited partners shall have a three percent (3%) interest in the capital, profits and losses of the limited partnership, said interest consisting of a gift of a three percent (3%) limited partnership interest in McINTOSH & SONS LIMITED PARTNERSHIP to each of them from DWAIN H. McINTOSH, one of the existing limited partners. The agreed value of each three percent (3%) limited partnership interest is \$44,817.00.

4. Pursuant to the provisions of the Limited Partnership Agreement, all the partners have given written consent to the admission of ARTHUR L. McINTOSH and DOUG McINTOSH as limited partners. Both of the new limited partners shall have a six percent (6%) interest in the capital, profits and losses of the limited partnership, said interest consisting of a gift of a six percent (6%) limited partnership interest in McINTOSH & SONS LIMITED PARTNERSHIP to

each of them from KENNETH W. McINTOSH, one of the existing limited partners. The agreed value of each six percent (6%) limited partnership interest is \$89,634.00.
