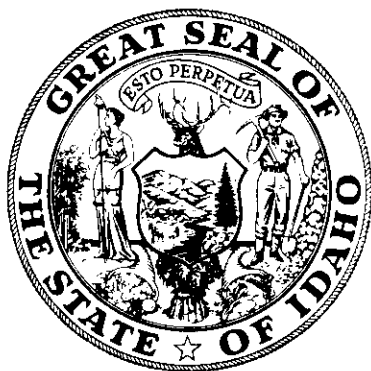

ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION

THE UNDERSIGNED, being the sole member of the Board of Directors and the owner of all of the issued and outstanding shares of the stock of ADVANCED COMPUTER SYSTEMS, INC.
