

NORMAN AND JOANNE MINISTRIES, INC.

Pursuant to provisions provided by the State of Idaho, the undersigned adopts the following Articles of Amendment to the Articles of Incorporation:

FIRST: The name of the Corporation is Norman and Joanne Ministries, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the officers and directors of the Corporation on August 30, 1993.

RESOLUTION: That Article Two be deleted and the following article be substituted.

ARTICLE TWO-PURPOSE AND OBJECTIVE

This organization is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

The purpose and objective of NORMAN AND JOANNE MINISTRIES, INC. shall be to convey and to declare to this generation the message contained in the Statement of Faith as recorded in these articles. This is to be accomplished through the work of the Corporation and by supporting other ministries and outreach groups whose vision, objectives, and structure are acceptable to NORMAN AND JOANNE MINISTRIES, INC.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986.

The support of other ministries shall be considered on the basis of the financial ability of this Corporation and acceptable methods and accounting by those considered for financial support.

The Corporation shall have the right to possess, buy, mortgage, sell, lease, barter, and exchange real and personal property, to borrow money, collect funds, receive gifts, and legacies as it may judge necessary for the attainment of these purposes and objectives, all in accordance with its constitution or as the same may be modified or amended hereafter.

RESOLUTION: That Article Nine be deleted and the following article be substituted.

ARTICLE NINE-DISSOLUTION

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

It is the intent of this Corporation that said organization under section 501(c)(3) be, namely, Full Gospel Assemblies International whose headquarters are located at RD2, Parkesburg, PA.
